CRITERIA FOR HEALTH INFORMATION EXCHANGE ORGANIZATIONS

- Foundational to executing Colorado's Health IT Roadmap is the agreed upon philosophy by the Office and the eHealth Commission to leverage existing infrastructure and investments for health IT and health information exchange.
- Updated criteria language based on feedback at February Commission meeting.
- This criteria outlines qualification for health information exchange organizations to receive funding for Roadmap initiatives, specifically the Advance Health Information Exchange Initiative and Unique Individual Identity.

CRITERIA FOR HEALTH INFORMATION EXCHANGE ORGANIZATIONS

- Organizations may apply to OeHI to be identified as a health information exchange organization for Roadmap efforts
- Onboarding of eligible providers for HCPF a separate but aligned process.
- Does the eHealth Commission approve this criteria?
