In February, stakeholders with technical experience and perspectives were invited to attend the Colorado Roadmaps enablers workshop. This workshop focused on identifying and describing the enablers that must be developed, implemented, improved, continued or discontinued in order to support the recently defined objectives for the Roadmap.









By understanding the infrastructure elements that need to be in place in the infrastructure to accomplish the objectives – the desired future state – and then by assessing the current state of Colorado's Health IT infrastructure, any gaps that need to be filled will be identified and prioritized. The core team will then develop a set of proposed initiatives to close those gaps. Over the summer, the core team will conduct one or more public meetings to receive input and comments on the proposed initiatives before they are presented to the eHealth Commission for approval.

Telehealth and e-Visits Reimbursement Parity



Are You Billing for Your e-Visits?

Currently under Consideration: HB17-1094

As of January 1, 2017 – providers are now able to bill for telehealth visits as they would any other in-person office visit (telehealth reimbursement parity). This law also removed the "150,000 or fewer residents" limitation, expanding reimbursement coverage to urban as well as rural areas. (HB 15-1029). Currently under consideration is HB17-1094, which would provide additional clarifications for covered telehealth, such as the exclusion of voice-only

telephone and texting, and that a health plan may apply the appropriate co payment, coinsurance, or deductible, but not exceed the corresponding amount of care that might have been delivered in-person.
