SHIE Goals

November 2023 - SHIE Contract Execution (The real fun begins!)

The purpose of SHIE is to integrate and exchange social care data and facilitate care coordination across technology systems. This process includes screenings that will be built into an assessment and care plan that will, in the end, provide users with a full referral plan including behavioral, physical and social health services.

OeHI's goals remain the same: we want to build on existing community networks, not replace them with new ones. Our objective is to meet each community where they are.

What's Next?

The SHIE team recently met with Resultant for a Contract Kickoff meeting! Our top priorities now are finalizing the SHIE product roadmap and project plan, and diving right into the work!
