- The only update from OeHI this month is that we are continuing to host Health IT Roadmap listening sessions. We awarded 25 organizations throughout the state to host community listening sessions. We are really hoping to get patient feedback and are excited to report out on that information when those are complete. OeHI has completed 9 site visits with health providers as well as libraries. You may be wondering why we are going to libraries - that is because we have the telehealth hub kits at 13 libraries around the state. It's been really neat to see how the different libraries have brought that into action. We will be doing another round of funding for those telehealth hubs in libraries for this next state fiscal year.
  - Cory Hussain: This was asked by one of the individuals at the sites and we were discussing this. You are collecting the data as part of these listening sessions. Are we going to be using audio recordings, transcriptions, and doing any kind of qualitative analysis on it?
  - Stephanie: We are taking notes during the listening sessions and our plan is to combine those and pull out themes and then send them back to the listening session participants to make sure that they can see how they were reflected as well as let us know if we missed something or if something isn't reflected there accurately.
