- **(Proposed Federal Rule) U.S. Office of the National Coordinator for Health Information Technology (ONC), General Overview: Health Data, Technology, and Interoperability: Certification Program Updates, Algorithm Transparency, and Information Sharing (HTI-1) Proposed Rule (4/2023)-** On 4/11/23, ONC released a proposed rule to implement provisions of the 21st Century Cures Act and updates to the Health IT Certification Program.
